Legal Notice of Planned Improvement

The City of Linton is developing plans for the construction of a multi-use trail project from the Linton City Park (aka. Humphreys Park) to the Greene County General Hospital in Linton. The location of the proposed multi-use trail is from the Linton City Park near CR 1100 W to the Greene County General Hospital. An additional segment of the multi-use trail will extend 0.08 mile, from where the trail heads north towards the hospital to CR 1000 W (Lone Tree Road). Another segment of muli-use trail will extend 0.11 mile south-southwest from Lezlie Lane to tie into the primary trail route. The typical section will include an 8 to 10-foot paved trail with 2-foot shoulders. The total length of the proposed trail is approximately1.3 miles, all in the City of Linton, Greene County, Indiana.

Approximately 2.24 acres of permanent right-of-way (ROW) and 0.24 acre of temporary ROW will be required. The project will not involve the displacement of any businesses or residents.

The maintenance of traffic (MOT) for this project will require short term lane restrictions along SR 54 and will follow all requirements per the *Indiana Design Manual Guidelines*. Access to drives and businesses will be maintained through the duration of the project. The proposed start date for construction is September, 2021.

The cost associated with this project is approximately \$1.8 million which includes preliminary engineering, right-of-way, and construction with both federal and local funds anticipated to be used. The Federal Highway Administration (FHWA) and INDOT have agreed this project falls within the guidelines of the Categorical Exclusion (CE) Level 3 environmental document. The project creates no major impacts to the environment. Preliminary design plans along with the CE document are available for review at the following location:
