NEW BUSINESS

Resolution 2021-17 - IMPA Abatement

A motion was made by Linda Bedwell to approve Resolution 2021-17 (A
resolution confirming the adoption of the declaratory resolution designating
an economic revitalization area application of the Indiana Municipal Power
Agency), 2nd by Les Newman. 4 ayes, passed.

Resolution 2021-18 - Banking Resolution

A motion was made by Linda Bedwell to approve Resolution 2021-18 (granting permission to the Clerk-Treasurer to open a bank account and close another), 2nd by Jeff Sparks. 4 ayes, passed.

A motion was made by Linda Bedwell to grant the Clerk-Treasurer permission to transfer \$100,000 from the Electric Cash Reserve into the new bank payroll account at Owen County Bank, 2nd by Tony Richards. 4 ayes, passed. Normal prior Electric Cash Reserve transfer authorities will be used once the Northwest Banking Account is closed).

Library Board Appointment

A motion was made by Linda Bedwell to approve the reappointment of Gayle Margraf to the Linton Library Board, 2nd by Les Newman. 4 ayes, passed.

Alley Closing




