### **Blighted Properties**

68th NW - James Anderson (Alva Anderson Life Estate)

Sam Drummy stated an invoice for cleanup of the property was \$6950.00 plus administrative costs and a motion was needed to proceed. The motion was made by Linda Bedwell for assessing the cost and clean up and seconded by Tony Richards. 3 Ayes, passed. Sam stated a demand letter will be sent to pay voluntarily within 30 days.

## 13th St NW - Dominick Iacobazzi

Mr. Iacobazzi was present at the meeting. Ron Lehman stated that Mr. Iacobazzi had a key to the first trailer but could not find the key to the second trailer on the property. Ron stated he did walk through the first trailer, and it was structurally sound. The portion of the porch that was hanging off has been removed. Ron also stated that Mr. Iacobazzi had sprayed weeds and had done some cleanup. Tony Richards stated he drove by before today's meeting and the camper shells, and a topper are still there, and the back of the yard is full of brush. After discussion it was decided to leave the property on the agenda for monitoring and to assess the cost (\$927.87) The motion was made by Tony Richards to leave it on the agenda for monitoring and to access the costs and seconded by Linda Bedwell. 3 Ayes, passed.

### Denman Property (Johnny Weaver)

However, Sam Drummy stated the city has assessed two mowing leans one for \$200.00 and another for \$300.00 before Cheyenne taking ownership and her wages were garnished for \$200.00 for one of the liens. Also discussed was the possibility of a cleanup lien on the property as well. Sam said he would check and see if there were any other liens on the property. Ms. Arnold stated that she pays over half the mortgage payment, but the property is not in her name. The mortgage company is inquiring into why this lien was not reported on the credit check and this is why she is here today trying to get the information. The lien is for \$927.87 for processing fees. Sam Drummy stated that he would send information to her regarding her inquiry.
